CERAMICS AREA — Tyler 128 COVID-19 related Policy

- **All students** coming to campus for any reason must pre-screen daily for travel history, COVID-19 history and COVID-19 symptoms beginning 14 days prior to arriving on campus for the spring 2021 semester.
- **Daily COVID Screening.** Students are asked to complete the [Medicat Health Check](#) on a daily basis.
- All students and employees coming to campus for any reason **must be tested each week** through campus surveillance testing. You should also let your instructors know you are not feeling well.
- Any student or employee who tests positive for COVID-19 or is a close contact with someone who tests positive for COVID-19, must isolate or quarantine and follow the guidance of the county health department where the individual resides. Please also refer to: [Isolation and Quarantine](#)

Please read, sign, and date at the bottom:

1. I will respect the need to control access and only enter when my instructor approved scheduled class time or the scheduled Open Studio Hours.
2. When using the space, I will wear a mask and use hand sanitizer upon entering.
3. I will keep my mask on at all times and use hand sanitizer as well as washing my hands frequently. Note: Cloth face coverings must only be worn for one day at a time and must be properly laundered before use again.
4. I will only sit at my assigned, numbered table. I will **stay at least 6 feet from other people at all times** in the studio. (Two arms' lengths is a good rule of thumb to approximate this distance.) No gathering in groups.
5. I will use the studio supplied disinfectant to clean the table surface and the chair before and after each use. I will make sure to wipe (two times) the table or wheel with a clean sponge after each use.
6. I will place my personal belongings on my table, keeping belongings close to me. I will keep provided gloves on my assigned shelf in this studio.
7. I will clean all my tools properly after each use. If I need to borrow any tool or equipment from the studio, I will make sure to wear gloves, clean and sanitize after each use.
8. I will not bring open food into the studio, and I will refrain from eating or drinking in the space. If I need to do this, I will go outside the classroom or to a campus space designated for this activity.
9. If I need to remove my mask. I will go outside and distance myself in a low traffic area, being mindful to avoid contact with others.
10. When using the restrooms, I will refrain from using my phone and will both wash my hands for at least 30 seconds, and apply hand sanitizer before returning to my classroom seat.
11. If I find myself struggling to get work done, I will reach out to my professors to get their help problem-solving ways to improve my performance.
