

New York State 2022-2023 Enacted Budget Highlights

- No reductions to 2021-2022 Direct State Tax funding levels
- \$53.0m across SUNY for new Full-Time Faculty and fringe benefit costs
- Support for growth in programs:
 - EOP
 - Mental Health
- Expansion of the Tuition Assistance Program (TAP):
 - Part-time students
 - Incarcerated individuals
 - Removing work requirements for childcare subsidies for students
- \$60m for one-time strategic investments in state-operated campuses, statutory colleges, hospitals, and community colleges (plan TBD)




New York State 2022-2023 Enacted Budget Highlights

- Elimination of the existing SUNY Tuition Credit (TAP Gap \$2.6m)
- Elimination of the "Excelsior Tuition Rate Lag"
 - Re-setting the rate of tuition to 2022-2023 levels
- Increased levels of capital investment (\$660m above the annual \$550m)
 - \$650m lump sum in Flexible Bonded Capital
 - \$10m for Educational Opportunity Centers (EOC)
- One-time investment in child-care centers for both state-operated campuses and community colleges (\$10.8m combined)


- Fully restored state tax support

 - Equity Compression: \$235,798 to 264 employees






SUNY Oswego NEW Student (FT&PT) Enrollment 2017-2022




Fall Semester First-Year Applied, Admitted, Deposited as of ~April 13th Each Year




Fall Semester Transfer Applied, Admitted, Deposited as of ~April 13th Each Year




First Year Student Applications by Region Fall 2018-2022




First Year and Transfer Student Applications Out of State, Fall 2018-2022*








Full Time International Student Applications Fall 2018-2022*







Graduate Students by Full-time/Part-time Fall 2017-2021




First Year Student Applications for Fall Semester Year to Date **SUNY Oswego Compared to SUNY Comprehensives 2022* and 2021**


Oswego College Foundation

- Endowment is currently over \$60.7 million*
- Raised over \$6.3 million thus far this fiscal year*
- OCF provided over \$3 million in support of students and campus
 - \$1.4m in student scholarship support
 - \$1.6m in support of campus programs and departments

- Tyler Hall Phase III: \$5.5m
- Penfield Lanigan Connector: \$76m
 - Penfield Library and Resource Center
 - Lanigan Hall Rehab
- Student Life Facility: \$30m
- Sheldon Hall Rehab: \$7.5m







Capital Updates: Design Phase

- Hewitt Hall Phase II (pre-bid): \$38m
- Mahar Hall Rehab (advertise for design May 2022): \$45m
- Hewitt Quad: \$5m
- Rudolph Road Steam Line: \$5m
- Critical Maintenance
 - Emergency Generators: \$2.5m
 - Roofs: \$2.1m
 - HVAC: \$1.4m





Capital Updates: Construction Phase

- Hewitt Hall Phase I- \$18m
- Sheldon Terracotta \$14m
- Hart Hall Upgrades \$1.3m
- Artville/Bookville Relocation \$1.3m
