IFR Reserves	\$1.5 million

Summary:

Rational Tuition Plan-\$200 annual increase

- •Assistance for UUP raises \$109 million
- Capital funding \$550 million (Critical Maintenance Projects)
- Excelsior (\$125,000 income level)



Concerns:

Projected NYS Budget Deficit

Procurement Legislation is undecided



Projected Financial Plan 2019-2020

SUNY Oswego Projected Financial Plan 2019-2020	
Rational Tuition Increase	\$1.7 million
Tuition Credit (TAP)	(\$300,000)
Minimum Wage increase impact	\$25,000
Projected Salary Raises*	\$2.8 million
Projected Deficit	\$1.425 million



Capital Budget:

- Capital funding \$550 million (Critical Maintenance Projects)
- Distribution methodology changed:
 \$153.4m distributed vs \$353.4m in 2018/2019 (Oswego Allocation \$5.4m)
 - \$396.6m: Campuses apply for additional funding





- Mary Walker Health Center-\$4.5m








In Design:


- Hewitt Hall (concept design)-\$65m

- Funnelle Hall (not capital funding) \$12m

- Sheldon Terracotta-\$8.6m

 - Roofs-\$2.1m
 - HVAC-\$1.4m
