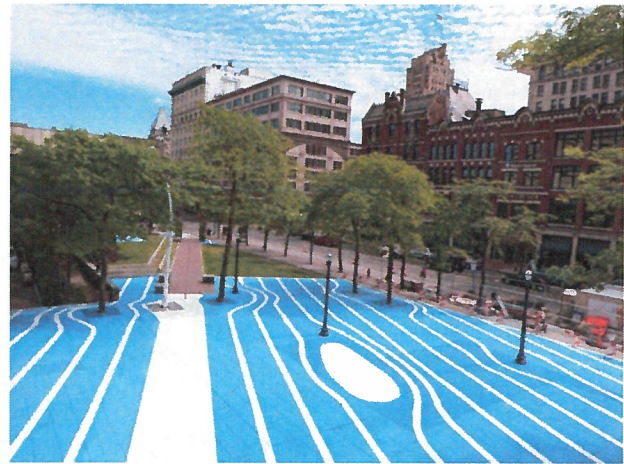
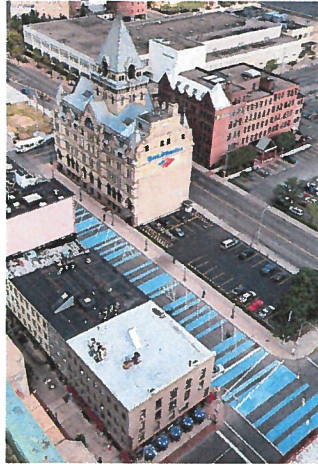
- 1. Welcome & Call to Order:**

  - a. *Universal bathroom committee (UBC)*
    - i. Sub-Committee would like to send out a campus wide survey to students to find out their options and needs on universal bathrooms.
      1. Missouri State University shared their survey and results with SUNY Oswego (see attached document).
      2. Mehran Nojan has given the approval to send out survey at the beginning of the Fall 2018 semester.
      3. Definition of universal bathroom should be fully defined in survey.
      4. Survey needs to go through Human Subject Committee due to potential future publishing and sensitive subject matter.
