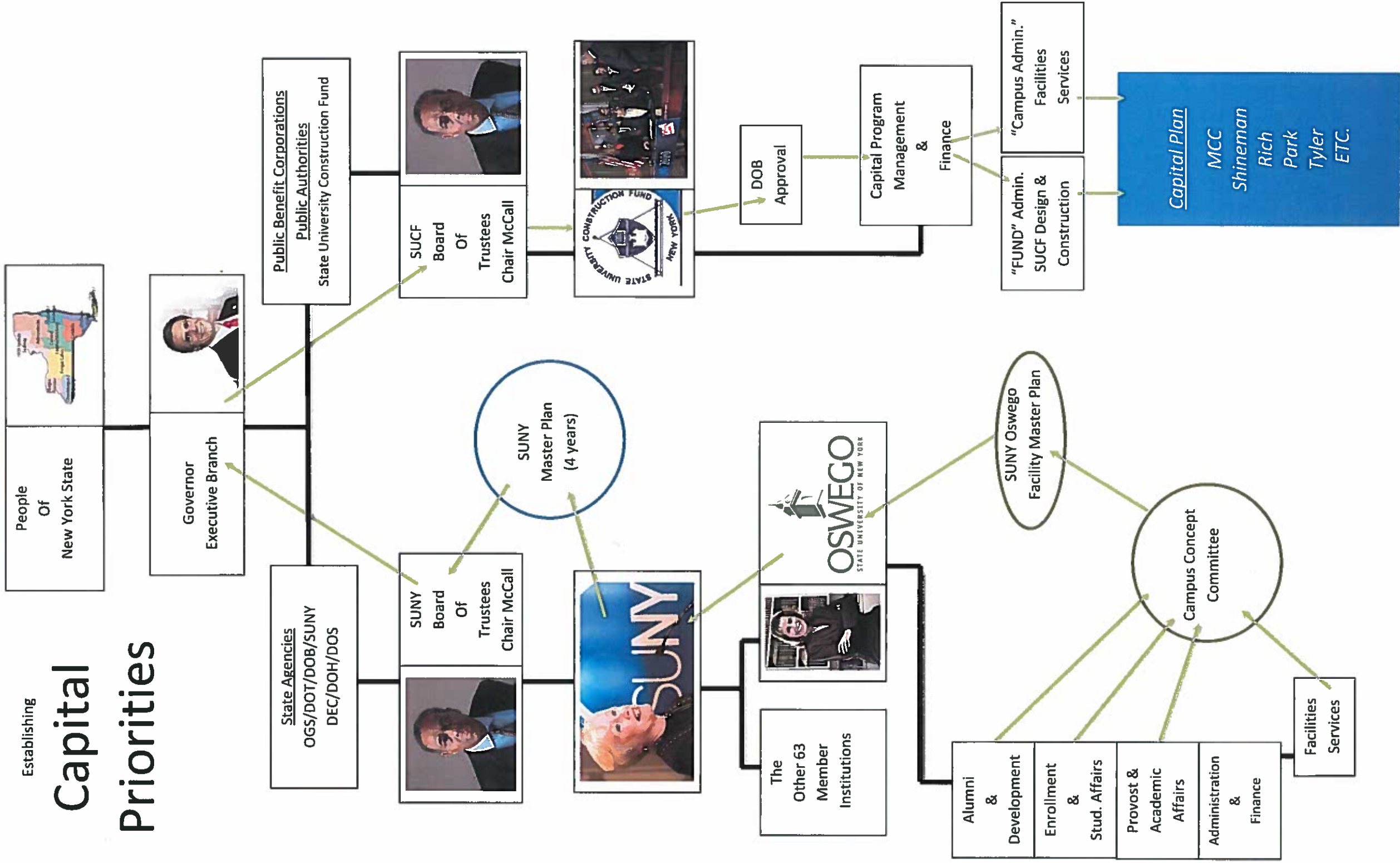

Campus Concept Committee

1. Art department students have created “Life on the Lake” murals that they would like to place on the exterior wall surrounding Tyler Hall.
2. The wall would need to be cleaned (sandblasted or painted) prior to installation of five 4’x4’ murals. In the future, another five murals would be installed on a rotating basis. Five new murals would be installed every few years to refresh the art.
3. Murals would be hung with a system so holes in the wall would only have to be drilled once.
4. M. Flaherty proposed an artist statement be placed next to the art or on the website.
5. A. Fenlon had concerns about the weather destroying the murals.
 - A. Bartell informed the committee that the murals are painted on hardwood and poly coated which will help to keep the murals looking new longer. This is another reason to refresh the wall every few years with new art.
6. The graffiti topic was brought up by a few members. Public art is prone to graffiti but the art department is hoping with the sense of campus ownership and the lack of vandalism currently on campus, the art should be safe.
7. M. Kryskow stated that students talk about the art on campus, they respect it, and it is a conversation piece.
8. J. Pretzat motioned to approve the mural installation; P. Caraccioli seconded; all approved.

 1. B. McTiernan spoke with Res Life and Housing and OLS to put together a committee with students to remove the litter from the shore of Lake Ontario surrounding the campus.

We are requesting to install a series of 5, 4'x4' murals along the North Wall of Tyler. At present, this wall has old, faded graffiti. We are proposing to cleanse this off the wall using sand blasting or power washing (or paint over if needed). We would then install the murals.

These murals were completed in a summer course with the theme referencing life along the waterways in Oswego.



Our intention is to place these murals in a way that we can replace them every couple years with a new work, thus reactivating the space in the same way that the sculpture garden does (the one located in the green space between Penfield and Marano Campus Center).
