Applications & Equipment - Natalie

Elections & Bylaws – Marcia for Larry Fuller

Marcia – The CTAB Executive Committee met and a discussion was put on the table that we make
changes to the Bylaws. We are not voting on it today, but this is an opportunity for you to take a look
and ask questions. Last year we had a temporary committee called Strategic Planning - that committee

met to prepare the Strategic Plan, which Sean has used as a good guide for his next steps. The Strategic Planning Committee was not active this year. We would like to use the Executive Committee as the Strategic Planning Committee. The Executive Committee would be in charge of working closely on the strategic plan with CTS.

- Sean The strategic plan had been an ad hoc committee and the committee never met within the past year, I see it as the executive committee would be responsible for the proper planning. We might want a new committee in a year when the President does her strategic plan.
 - 1. The Executive Committee is responsible for ensuring that Information Technology policy, strategy, operations and projects are defined, measured, and executed, and report to the Provost and Vice President for Academic Affairs on such matters. Additionally the Executive Committee advises the Provost and Vice President for Academic Affairs on innovations in campus technology as well as issues and concerns addressed by the Campus Technology Advisory board. The chair of the Board, the chairs of the Standing Committees, and the CTO are members of the Executive Committee. A representative from the Information Technology Council is also a member. The chair of the Board shall chair the Executive Committee. The Executive Committee will participate in the review of the Chief Technology Officer.
- Also in the bylaws the Technology Planning Committee will be resolved. The Executive Committee will take on that responsibility too.
- Voting on the aforementioned changes to the bylaws will take place at the next CTAB Meeting, May 9, 2014.
- Marcia In addition to the Bylaw changes, we will be having elections for three important positions:

Education - John Kane

ITC Report - Mark Springston

- At the meeting yesterday, we discussed the NY Alert Messaging system, some students misinterpreted the alerts that went out for classes being cancelled. Sean met with Julie and Nick to review the messages that went out. The second message was clearer.
- Brenda What about those that teach at 11:30 if classes are cancelled at noon starting at noon or after.
 Marcia we are improving with the communication. Sean if the class starts at 11:30, the class will continue until it is over.
- Natalie reported on the new mobile site and Rave Guardian.
- Sean talked about Degreeworks, not all the info but the outline of the plan

- Sean shared the planning parties this summer, wireless upgrades this summer, and the summer CTS project list.
- Also had a discussion about Lynda campus at SUNY Oswego, there is an implementation plan and that is being updated as we go, we are assessing how many users are using it. As of this week there were 423 new users in February, 83 new users in March; that is 12 percent of our total users; 1923 hours of video viewed, 26,481 videos watched.

Campus Technology Services Report

Mike reported on the Heartbeeed Virus.

- Heartbleed virus is a security vulnerability that is out it has been out since 2012 it deals with any system that runs SSL secure socket layer, it helps encrypt transmissions that goes between you and a browser.
- Someone can go in and encrypt anything that is going over the internet. It became big news late last week, the fixes came out this week we found four of our systems that were vulnerable this week, two have been fixed, one is in the process of being fixed and one is currently offline. We should be ok, we have looked and our services. One item that came out, NYS and federal we changed passwords, you don't know what sites were vulnerable. It could be your bank, credit card, Walmart, Amazon, etc. Open SSL is run on vast majority or UNIX operating systems. We have had some potential vulnerabilities.
- Dave McQuin Is there anything that can be done on personal systems?
- Mike it is the other end, the only thing is that chrome has a plug in that you can install it is called Chromebleed. From the client, customer side there is really nothing you can do. There is also another one that is starting called Crime.
- Pat McNeill Will an email be sent out to everyone once everything is fixed? Mike Yes, you may want to do some searching to see what institutions were affected by this. ITEC sent out an announcement that they were fine.
- Marcia if you are using a mac, are you still vulnerable. Mike yes, it is when you log into a system.
