Summer Program Policies and Participation Agreement

2022

All students accepted to SUNY Oswego through the Educational Opportunity Program (EOP), are required to attend the mandatory EOP Summer Program. Admission to Oswego for Fall 2022 is contingent upon your successful completion of the Summer Program. Successful completion is achieving a score of 80 or higher (out of 100) for the summer program curriculum.

The EOP Summer Program is designed to facilitate students' successful transition from high school to college. Through our rigorous curriculum and course work, students enhance and build skills specific to college-level learning. Students stay on campus during the entire summer program including weekends (no visitors are permitted). In addition to our Educational Opportunity Program professional staff and instructors, we train and hire peer leaders to live and work with our students throughout the summer program. Our peer leaders serve as mentors to our freshmen during the summer and into the academic year. The summer program serves as the foundation of our program and marks the beginning of your life as a life-long member of our EOP family.

The Summer Program is a four-week program (July 1st – July 29th). Students must stay on campus and will reside in the residence hall for the entire residential part of the program (including weekends beginning July 5th – July 29th). July 1st will be a virtual day before arriving on campus.

- Students will receive 3 academic credits and a letter grade for the summer program.
- You will be housed in a residence hall on campus for the summer program only. Consistent with the academic year, there are Resident Assistants (RA) assigned to each floor. EOP peer leaders are also assigned to each floor.
- You will be eating in one of our residential dining facilities.
- We have recreational and social activities planned as part of the summer schedule.
- Classes are held in-person and in various classrooms across campus similar to the academic year.
- Follow COVID-19 protocols and policies listed in the [Oswego Forward/COVID-19 Information](#).
Note: COVID-19 protocols are subject to change.

Summer program faculty members are available and willing to discuss course material outside of class. Additionally, we have tutors available to help you with your academic materials. You will meet with your Academic Planning Counselor (APC) throughout the program and can discuss any concerns you may have.

Important policies to know for the summer program:

- Students are not allowed to bring a car to our summer program.
- Students are not allowed to go home on the weekends. There are scheduled activities on the weekends that students are expected to participate in as part of the program.
- Family and guests are not allowed to visit during the program.
- Students are discouraged from leaving campus alone. They should be accompanied by another student(s) and inform their peer leader.
- Curfew: Students must be in the residence hall by 11:00 pm, Sunday – Thursday and 1:00 am on Friday and Saturday.

- Students are to adhere to all college policies, rules and regulations as laid out in the [College's Student Handbook](#), [Resident Student Handbook](#) and the COVID-19 protocols and policies listed in the [Oswego Forward?COVID-19 Information](#). Note: COVID-19 protocols are subject to change.

Academic Responsibilities:

- I will demonstrate respect on a daily basis to myself, my instructors and my peers.
- I will respect my instructor's attendance policies. In addition, I will attend all classes prepared. This includes reading and completing all assignments. I will strive to do my best in each class.
- I will arrive at my classes on time and stay throughout the class period.
- I will respect appropriate college classroom behavior as defined by my instructors.
- I will attend tutoring and study hall sessions.

Program Responsibilities:

- I will meet with my assigned EOP Academic Planning Counselor (APC) during the summer program. I will discuss with my APC in a timely manner, any personal, academic, or financial problems that could affect my performance at SUNY Oswego.
- I will complete and submit all required applications and financial aid documentation as outlined by the EOP, Financial Aid and Health Center offices.
- I will participate in all EOP Summer Program academic programs and activities.

EOP students are expected to comply with all policies, rules, regulations and directives of SUNY Oswego and its related entities, including but not limited to those policies set forth in the [College's Student Handbook](#) and, [Resident Student Handbook](#) and the COVID-19 protocols and policies listed in the [Oswego Forward Plan](#). Failure to comply with these requirements may result in programmatic action/dismissal in conjunction with campus disciplinary action.
