### *Oswego Forward: A Plan for Fall 2020 Restart at SUNY Oswego*

July 27, 2020

**Whereas**, SUNY Oswego is a highly regarded, nationally recognized learner-centered, residential academic community with a long-standing history of prioritizing the health, safety and wellbeing of all of its community members; and

**Whereas**, SUNY Oswego, like hundreds of other colleges across the nation, was asked to develop a plan to restart on-campus operations in Fall 2020 in the midst of the ongoing COVID-19 pandemic; and

**Whereas**, SUNY Oswego faculty governance leaders, faculty members, staff and administrators from all divisions of the College joined together to develop and write *Oswego Forward: A Plan for Fall 2020 Restart at SUNY Oswego* in alignment with all local, state and federal reopening guidelines; and

**Whereas**, *Oswego Forward: A Plan for Fall 2020 Restart at SUNY Oswego* (July 1, 2020) was approved by the State University of New York and New York State; and

**Whereas**, SUNY Oswego leadership, faculty members and staff continue to work closely and collaboratively with all external stakeholders including county and hospital health officials; emergency personnel and management teams; and elected officials and community and business leaders to prepare for a safe and welcome return of students and employees to campus this fall; and

**Whereas**, SUNY Oswego students show respect for themselves and others and agree to uphold the *Oswego Forward* Pledge to the best of their ability; and

**Whereas**, all returning SUNY Oswego campus community members will be asked to agree to abide by the principles of the Oswego Forward pledge including viewing this pandemic as an unprecedented threat to us all and also as a profound opportunity for SUNY Oswego campus community members to create new ways to work together and to emerge stronger, healthier and better than ever before; and


