Official Rules — Step Up Challenge

To be eligible: 1) Pledge at least \$1.00 per week, or increase your pledge from last year by \$1.00 each week (\$52 per year). 2) Complete your Pledge Form (other side) and return the top 2 parts in the enclosed envelope, and 3) Complete the form above with your PICK YOUR PRIZE choice checked off.

All Step Up Challenge entrants will be eligible for daily prizes. These prizes will be awarded by random drawings of all processed entries. Drawings will be conducted daily, Monday through Friday, beginning Monday, October 3, 2016 and ending Friday, January 13, 2017. Daily prize drawings will be suspended for holidays on November 11, 24 and 25 and December 26, 2016 and January 2, 2017. All entries received prior to 4 p.m. each Wednesday will be processed for inclusion in the daily drawings beginning the following Monday and continuing for drawings until the end of the sweepstakes.
